As you are well aware, commodity costs in general can vary significantly month to month. Specifically, as it relates to Nickel, the February 2020 LME Nickel Cash Average Price was above the base of \$3.00/LB, and Copper was above the base of \$0.50/LB. Also, the typical surcharges in place for FeCrAl alloys have been adjusted for the month. Consequently, the below metal surcharges will apply for all orders shipped during the month of March 2020:
